Come now Plaintiffs, through counsel, and file this Notice of Supplemental Authority in further support of Plaintiffs' Response in Opposition To Defendants' Second Rule 60(A) Motion For Clarification Of Order On State's Motion To Dismiss ("Plaintiffs' Response"), submitted July 27, 2022. Thereafter, on August 12, 2022, the Montana Supreme Court handed down its decision in *Sister Mary Jo McDonald, et al v. Christi Jacobson*, 2022 MT 160 (attached), wherein the Supreme Court affirmed the District Court's determination that HB 325, passed by the 2021 Montana Legislature, is unconstitutional and enjoined its implementation. *Id.*, ¶¶ 1, 4, 58. Thus, *McDonald* supplements the arguments and authorities at pages 3, 5, 6-7, of Plaintiffs' Response.
